### III. Attestation 兹证明

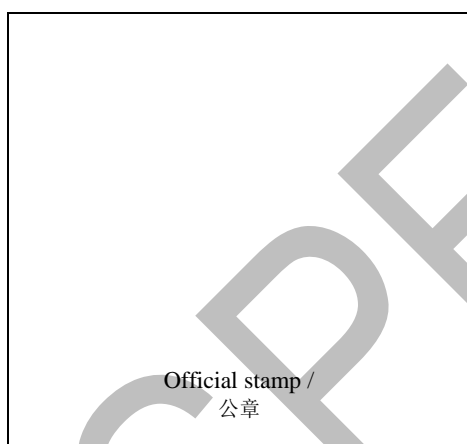
I, the undersigned official veterinarian of Finland hereby certify that: / 芬兰官方兽医在此证明:

1. Finland is free from foot and mouth disease, rinderpest, Rift Valley fever, contagious bovine pleuropneumonia, vesicular stomatitis, bovine tuberculosis, bovine brucellosis and enzootic bovine leucosis. According to OIE classification Finland has a status of negligible risk for BSE. 芬兰没有口蹄疫, 牛瘟, 裂谷热, 传染性牛肺疫, 水泡性口炎, 牛结核病, 布鲁氏杆菌病, 流行性白血病等疾病。根据世界动物卫生组织 OIE 的划分, 芬兰基本不存在疯牛病的风险。
2. The raw material of the milk product(s) was obtained from clinically healthy animals at dairy farms which are free from brucellosis, tuberculosis, paratuberculosis and anthrax during the past 12 months. 该乳制品的原料奶是来自过去 12 个月中未发生布鲁氏菌病、肺结核、副结核、炭疽热等疾病的牧场中的健康奶牛。
3. The milk product(s) was manufactured and stored in an establishment approved by the competent local public health and veterinary authority. The manufacturing establishment, the storage establishment and the manufacturing, packing, storage and transportation of the product(s) are under supervision of the competent local public health and veterinary authority.  
该产品的生产和贮藏所在地得到了当地公共卫生和兽医局的批准。产品的生产基地, 贮藏场所及产品生产, 包装, 贮藏及运输过程, 均受芬兰当地公共卫生和兽医局的监管。
4. The milk product(s) was manufactured from milk that received a pasteurization treatment (min. 72 °C / 15 seconds) or a time/temperature treatment of at least equivalent effectiveness. 该产品的原料奶经过 72°C15 秒的巴氏杀菌, 或者具有同样杀菌效果的时间/温度处理。

The milk product(s) has been manufactured in accordance with the existing Finnish and EU food regulations and is fit for human consumption. The product(s) is in compliance with the legislation of the People's Republic of China as certified in this veterinary health certificate. According to monitoring programs the product(s) contains no harmful levels of contaminants. 该产品按照芬兰和欧盟的现行法律法规生产, 适合人类消费。该卫生证书中描述的产品符合中华人民共和国有关法律和法规规定。根据有关监控体系, 该产品不含有害水平的污染物。
