<p>I, the undersigned Official Veterinarian do hereby certify that:</p> <p>a) the animals, from which the goods were derived, were born and raised in the territory of Finland or in another European Union member state approved to export the goods to Hong Kong;</p> <p>b) the goods originate from registered farms and approved plants which are under the supervision of the competent authority in areas that were not under restrictive measures due to OIE-listed diseases that poultry is susceptible to;</p> <p>c) the poultry have been kept in registered farms and slaughtering plants free from Newcastle disease and Avian influenza and not situated in a Newcastle disease or Avian influenza infected zone at least for the past 6 months;</p> <p>d) the poultry, from which the goods were derived, were subjected to ante and post mortem veterinary inspection by official/authorised veterinarian;</p> <p>e) the goods derive from facilities approved by the competent authority for export purpose;</p> <p>f) the goods have been produced hygienically under the conditions and control laid down in the relevant European Union legislation in force;</p> <p>g) the goods were packed and transported under hygienic conditions;</p> <p>h) the goods have been subject to the testing programmes for harmful organisms, veterinary drug residues and other toxic substances administered by the competent authority. The results of the tests meet the European performance standards and have not provided any evidence as to the presence of chemical/drug residues or toxic substance which would be harmful to human health. The goods were found to be sound, wholesome and fit for human consumption; and</p> <p>i) all necessary precautions were taken to avoid contact of the goods with any source of avian influenza virus.</p>
