
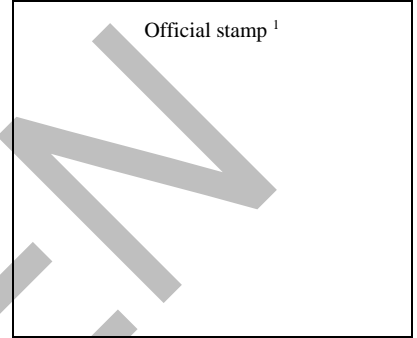

I, the undersigned official veterinarian of Finland, hereby certify that:	
<ol style="list-style-type: none"> <li>1) The slaughter animals have been subjected to ante-mortem and port-mortem veterinary inspection by an official veterinarian in Finland, the slaughtered animals were healthy, no clinical signs of infectious disease were found.</li> <li>2) The dressing, preparation, processing, packing and labelling of the meat / meat products were carried out with such precautions and with such material and equipment and in such manner that they are safe for human consumption.</li> <li>3) The meat / meat products are fit for human consumption.</li> <li>4) The meat / meat products come from animals born, raised and slaughtered in Finland.</li> <li>5) The meat / meat products come from animals originating from farms that have been free from swine vesicular disease, classical swine fever, teschen disease, tuberculosis and trichinosis for the last twelve months.</li> </ol>	

- 6) Finland has been free from foot and mouth disease, rinderpest and African swine fever for at least last six months.
- 7) The meat / meat products are free from bacterial and parasitic disease including taeniasis and trichinellosis.
- 8) Radioactivity and hormone residue levels of the meat / meat products are below the maximum limits regulated in the Finnish and EU legislation.
